

Stopping the Planned Genocide

The actions required fall into several categories and everyone will find at least one of them applicable to their status and abilities.

I. Spread the News.

Everyone, everywhere: talk about it to everyone you know. Copy the videos and other documents and distribute them to everyone you know. Keep talking about it. Follow www.healthfreedomusa.org and similar sites and keep talking the news as it happens. Keep the subject alive – don't let it be buried by soap operas.

II. Legal Action.

Local, everywhere: bring criminal charges of actual bodily harm against all water companies who are adding fluorides to the drinking water and all officials who have supported this. Detailed scientific help is to be found upon many websites, just google "fluoridation the dangers" to start.

Local, Canada: write to Queen Elizabeth AND to Prince Charles asking for the refusal of the royal assent should C.51 be passed. The position of a constitutional monarch is that of the last bastion of defence between a people and their government. Whenever the Queen has made plain that she sees problems with giving assent to a proposed law, the bill has quietly been dropped.

Local, Canada: this will need to be checked with constitutional lawyers but there may be the option of charging certain members of the Canadian government with treason over this matter! A law which has not yet been used this century but is still there to be used to prevent the abnegation of sovereignty to, in this case, a commercial enterprise in the form of the pharmaceutical conglomerates. Check your local laws – this may also be possible elsewhere.

Local, USA: Why does Monsanto get a \$2 billion annual subsidy from the Bush administration? Charges of malfeasance in office could be appropriate.

World: Charges of crimes against humanity certainly against Monsanto would be very easy to prove: They have already killed thousands for profit and maimed hundreds of thousands. Although the pharmaceutical companies have purchased legislation from the Bush administration granting immunity in the USA from any legal action for their crimes, this would strengthen similar actions against them in the World Court (if they've done nothing wrong, why do they need such special protection?)

To do all these we need some very knowledgeable lawyers and some sizeable funds, especially with the World Court actions as garnering and presenting the evidence is going to be expensive. Everyone can participate in this. Even ten dollars a month from ten million people is a lot of money! I, herewith, commit \$100.00 per month to the fighting fund as soon as it is organised. Someone out there will have to find and co-ordinate the lawyers. Since I stopped practising law in 1985 to take up my true profession, my contacts are meagre.

III. Disempower Codex Alimentarius

There are at least two ways of making Codex Alimentarius impotent:-

Everyone, everywhere: get yourself a piece of land and start growing your own vegetables. Codex Alimentarius permits the consumption of clean, vital foods only if grown where they are consumed. It will be a crime to cook them – you will only be permitted to eat them raw – so choose your varieties wisely.

There are many stories of great saints who never ate anything for years and years. Verification in an absolute sense has proved to be elusive. However, the work being done on the explored fringes of Quantum Field Theory makes it very plain that it is not only possible but that the universe would have to be structured very differently to the way in which it is for it to be impossible. All we need to know, therefore, is how to do it. What surprised me is how easy it is once you know how.

Now, this is initially going to be easier for some than for others and there is absolutely no need to "go the whole hog" and to stop eating altogether – what's needed is much easier than that. began to do it as well. There was no way that the distant monkeys could have seen or heard what those on the first island had learned. The information was so well established in the Zero Point Field that it became "common knowledge" to all and all did it without thinking about it.
